**Welcome to the Frederick Indoor Sports Center, *Where It's Always GAME ON!***

The Adult Sports League Programs at the Frederick Indoor Sports Center (FISC) are designed to be the most organized, comprehensive, and safe Recreational Sports Programs in the area. FISC offers a variety of sports and activities intended to encourage players to participate regardless of athletic ability or sport knowledge. FISC provides structured and rewarding recreational opportunities in men's, women's, and co-ed programs. League participation is open to all eligible FISC Members and Guests. Standards are enforced to maintain the integrity of the sport, and to keep all League rules within the FISC requirements. This Handbook provides a guide to those standards. All activities, policies, and rules are designed to uphold the best interests of FISC Leagues. All participants must abide by the policies and rules described in this Handbook. Every Member and Guest is responsible for learning and adhering to the policies set forth in this Handbook.

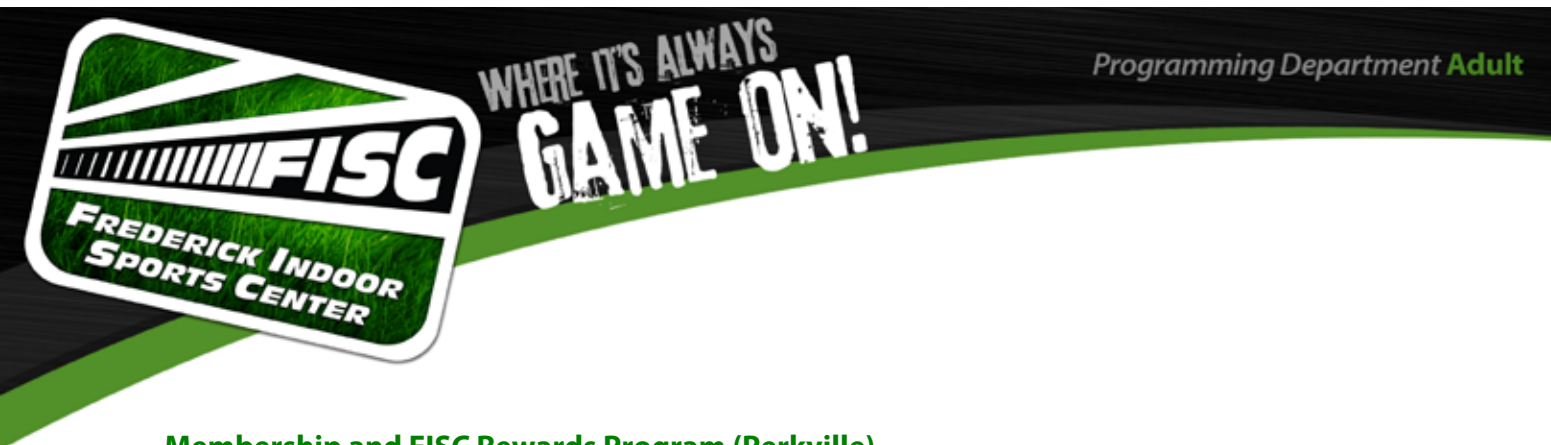

**General Facility Rules**

1. **No outside food & drink allowed.**
2. NO smoking & tobacco products.
3. No profanity or negative comments to officials, players, coaches or spectators.
4. No running, playing ball or use of sports equipment anywhere else but the fields.
5. No unattended youth under age 18.
6. No spitting.
7. No chewing gum on the fields.
8. Renew. Reuse. Recycle. Or at least use the garbage cans!
9. No fighting. No excuses.
10. Be a role model—exhibit good sportsmanship at all times.

**Eligibility for Participation - FISC ID/PERK\$ Card**

FISC is a Membership facility and all Members are required to maintain a FISC ID/PERK\$ card. In order to be eligible to participate for each game/match, an eligible participant must check-in with his/her current FISC ID/PERK\$. Participants who fail to maintain a current, valid FISC ID/PERK\$ Card will not be permitted to participate in that game/match (a Driver's License or valid Government ID may be accepted, in order to be eligible for a game/match but no Perk\$ will be awarded).



### Membership and FISC Rewards Program (Perkville)

Get your card online (Youth or Adults) or at the FISC Welcome Desk. FISC utilizes a Member ID system to manage the ¾ of a million annual visitors and patrons, who use the facility to participate in leagues, camps, clinics, events, fundraisers or visit the Replay Café. All FISC Members automatically earn PERK\$, through the Perkville Rewards program. Adult: \$25 or 500 Perkville Points  
Youth: \$15 or 250 Perkville Points

*Additional monthly Membership fees vary based upon your interests and level of participation.*

### Guest Player Policy

The Guest Player Pass policy has been revised so players can redeem Perkville points to invite a friend.

Adult Guest Player pass: \$15 per guest = 250 Perkville Points  
Adult Pre-Paid 4 Pack Guest Player passes: \$50 = 750 Perkville Points  
Youth Guest Player Soccer/Field Hockey pass: \$15 per guest or 250 Perkville Points  
Youth Guest Player Lacrosse pass: \$20 per guest or 300 Perkville Points  
Use Perkville to renew FISC ID/Perk\$ Card and/or purchase Guest Player Pass.

### Division of Sports

FISC Leagues are designed to offer and encourage players to participate in as many teams as possible. In order to do so, the program is able to offer three leagues: Men's, Women's and Co-Ed. Most rules for all sports will remain the same for both Men's and Women's leagues with slight modifications where necessary.

Most sport leagues are separated into three divisions:

- The "**Premier**" Division: Bring your "A" game. This is the highest level of competition. Top finishing teams will be offered prizes including t-shirt, coupons from sponsors and/or other valuable goods.
- The "**Champions**" Division: Recreational play with a competitive spirit is what this division is all about. Top finishing team will be offered prizes including: choice of t-shirt, coupons from sponsors and/or other valuable goods.
- The "**Masters**" Division: Nope, I'm not going to hang up my boots, ever! Players are required to overly embellish highlights of the match while enjoying weekly specials in the Replay Cafe.

Basic steps include:

1. Get a FISC ID/Perk\$ Card by visiting the FISC Welcome Desk. A FISC Staff person is ready to help you start the process!
2. Receive 4 FREE Guest Player Passes. We're happy you chose FISC! Bring a friend with one of your free passes!
3. Post an ad in the FISC Classified Ads. This is a great way to connect with other players.
4. Use a FREE Guest Player Pass to get connected with a team. Remember, you have four complimentary passes!
5. Once you connect with a team, sign up anytime and the session fee will be prorated.

### Team Captain's Role

Programming Department. This includes taking on the responsibility of the administration of his/her team and the behavior of each and every team member on and off the playing field (team members also extend to include coaches and spectators). Team Captains are responsible for understanding, and communicating to their teams, the policies that govern the FISC Leagues, as well as the specific rules that govern each sport. Having a good understanding of the program policies and sport rules will help facilitate and further aide a team's participation to be an enjoyable and worthwhile experience.

### Sportsmanship

Since the mission of FISC Leagues aims to encourage increased participation, the spirit of competition is important and will be assessed for every team during each scheduled game/match. Sportsmanship is vital to the conduct of every contest. In order to encourage proper conduct during games, officials, administrative personnel, and supervisors shall make decisions on whether to warn, penalize or eject players or teams for poor sportsmanship. These decisions are final. The FISC administrative staff will rule on further penalties as a result of unsportsmanlike conduct.

### Forfeit and Defaults

If a team or player fails to appear at the appointed place and time the Referee on duty shall declare the contest forfeited to the team or contestant ready to play (as long as that team has the required minimum number of players checked in). All teams are required to have within two players of the required field minimum at the scheduled game time.

### Ejected and Suspended Participants

Any player, spectator, or other visitor may be ejected by game officials or other FISC staff for any conduct deemed unsportsmanlike or outside of the spirit of the rules. An ejected person is immediately ineligible for ALL sports and activities.

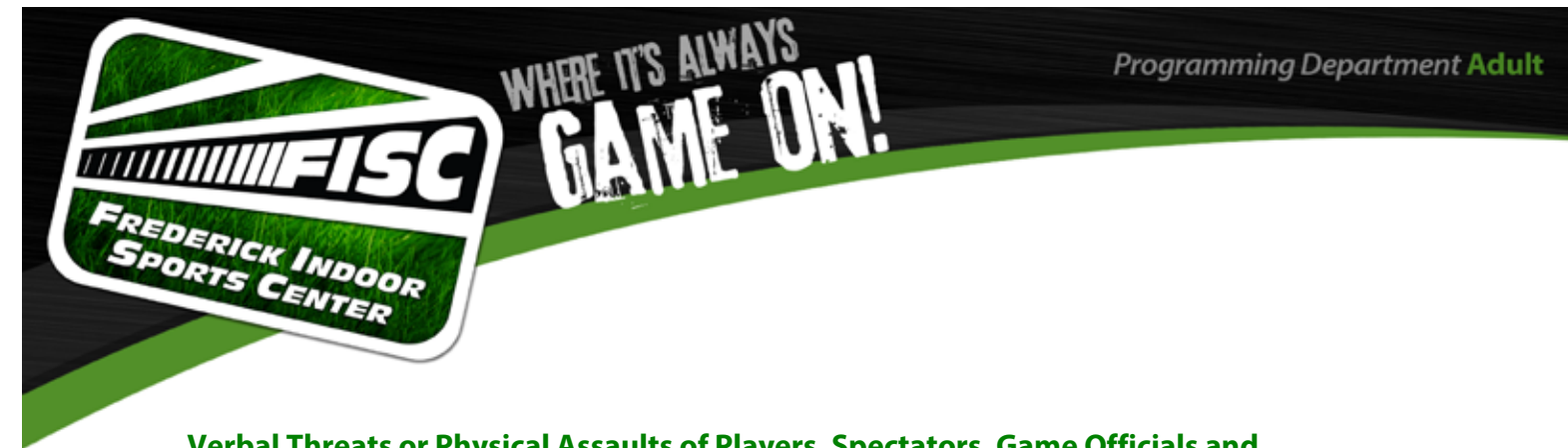
Any participant who is ejected must exit the playing field immediately. The Referee on duty will address the situation(s) with the ejected individual(s) and also communicate what the required process is for reinstatement. Even after an ejection, players will still be held accountable for their actions and behavior, which may be noted by FISC. Once a participant is ejected from an event he/she is ineligible until the reinstatement process has been complete and all suspensions (if sanctioned) are served.

### Appeal Process

A one (1) week or less suspension may not be appealed.

Any suspension beyond one (1) week may be appealed in writing by completing the [Appeal Form](#) and must be accompanied by a \$25 administrative review fee. No appeals will be added to the Player's FISC account.

*A non-biased three (3) person committee will review all appeals within 72 hours of the submission of the appeal. ALL DECISIONS MADE BY THE COMMITTEE ARE FINAL.*



### Verbal Threats or Physical Assaults of Players, Spectators, Game Officials and Other FISC Staff/Patrons

Anyone who threatens or physically assaults a spectator, player, official, or supervisor will be automatically suspended for a minimum period of one (1) year from the date of the incident.

You may appeal the suspension in writing by completing the [Appeal Form](#) and must be accompanied by a \$25 administrative review fee. No appeals will be reviewed unless the fee is paid and should the suspension be overturned, a \$25 credit will be added to the Player's FISC account.

*A non-biased three (3) person committee will review all appeals within 72 hours of the submission of the appeal. ALL DECISIONS MADE BY THE COMMITTEE ARE FINAL.*

### Inclement Weather

While winter weather is sometimes a welcome change and invitation to slow down from our hectic schedules, we know no one likes to miss game day at FISC, due to a few flakes!

To better serve you, and in response to what we know you've been asking for, we've revised our inclement weather policy to allow for a limited number of make-up games for any games missed due to weather-related closings. Here's what you need to know:

Safety First! FISC will make decisions on closing based on safety for all patrons and staff.

Read your email! Announcements will be made at least two hours prior to any scheduled event(s), and all patrons with registered e-mail addresses will receive notification via e-mail. Check [frederickindoor.com](#). To check the status of events at FISC, visit the FISC website (News & Events section), and Facebook page.

### Make Up Games:

FISC has built in time in future session schedules to allow make up days for a select number of make-up games. However, given the complexity of the schedules, which are set one year in advance, and volume of play on our fields, special requests cannot be accommodated.

Therefore, each team affected by a weather closing may have only one option for a make-up timeslot, if slots are available. If we are unable to reschedule your slot, FISC will award each affected player 250 Perkiwille points, a value of a Guest Player pass.

### Alcohol, Drugs and Tobacco Policy

Possession or consumption of alcohol (except when purchased and consumed at the Replay Café) or drugs at FISC facility is prohibited. Furthermore, all forms of tobacco are prohibited at any and all FISC League venues unless otherwise specified. Consumption of alcohol or drugs either at the game site or prior to the game will not be tolerated. Team Captains and participants are responsible for cooperating with FISC Staff in the event a team member or spectator is suspected of alcohol, drug or tobacco use. Any violation or failure to cooperate with this policy could potentially result in suspension.

### Ethnic Intimidation Policy

FISC **WILL NOT** tolerate any individual displaying any act of “malicious intent” towards a particular race, color, religion or national origin of another individual or group. If any individual displays such behavior, that individual will immediately be suspended from participation and will be processed to the full extent through the FISC Suspension Policy (noted above).

### Risk Management

As with all physical activity, there are inherent risks while participating in Leagues at FISC. Since participation is on a voluntary basis, FISC will NOT accept responsibility for injuries sustained while participating in any of the program offerings.

It is the responsibility of the participant to determine if any of their health conditions make it inadvisable to participate in any of the activities offered through FISC Leagues. FISC does not assume that responsibility. It is strongly recommended that all participants obtain a medical release from their physician.

For all sports and activities operated through FISC LEAGUES, participants are required to read and sign a [Participation Waiver](#). Any and all injuries sustained while participating in FISC should be reported to a FISC Staff member immediately. Once reported, an accident report will be completed and kept on file.

### Reserve Clause

FISC reserves the right to change and amend any policy or rule, as seen necessary. Influencing factors may include participant safety, program needs and incidents that are uncontrollable by nature. FISC reserves the right to rule and make judgments on all interpretations pertaining to League sports rules, regulations, eligibility and disciplinary action. The decision of FISC is final.
